The Climate and Clean Air Coalition was established in 2012 to treat short-lived climate pollutants as an urgent and collective challenge. Our approach integrates climate action and air quality efforts, which helps countries maximise national benefits, deliver the 2030 Sustainable Development Goals and increase ambition to meet the Paris Agreement goal to limit warming to 1.5° Celsius.

## OUR PARTNERS

Since 2012 we have grown into a global network with over 300 partners and actors carrying out activities around the world and across economic sectors.

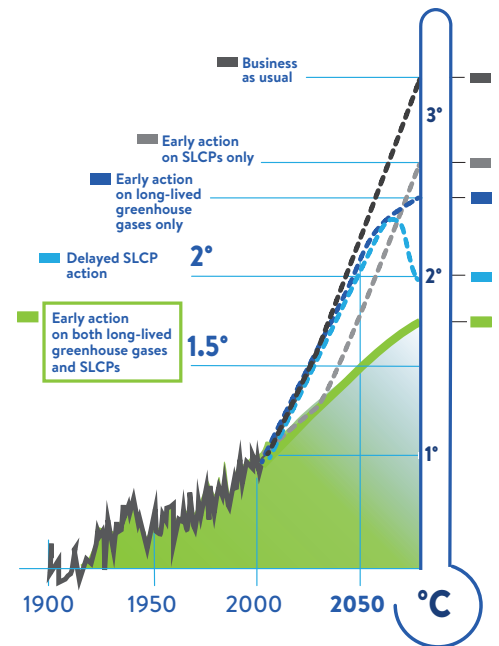
Participation in the Coalition is voluntary and open to governments, subnationals, intergovernmental organisations, financial institutions and civil society organisations that commit to address short-lived climate pollutants collectively and individually.

## WHAT WE DO

The Coalition focuses on four key strategies to achieve real and ambitious benefits for the climate and clean air:

- Enabling transformative action by providing knowledge, resources, and technical and institutional capacity to act
- Mobilising support for action through advocacy at all levels of government, the private sector and civil society
- Increasing the availability of and access to financial resources to support the successful implementation at scale
- Enhancing scientific knowledge to help decision-makers scale up action and promote the multiple benefits of action

## THE PATHWAY TO 1.5°C



Fast action on all pollutants contributing to climate change will achieve the Paris Agreement temperature targets and provide benefits for:



### CLIMATE

0.6°C avoided warming by 2050



### HEALTH

2.4 million avoided premature deaths annually from outdoor air pollution



### FOOD SECURITY

52 million tonnes of avoided crop losses from 4 major staples per year



### SUSTAINABLE DEVELOPMENT GOALS

Contribution to meeting the SDGs related to air quality, health, and food security

## ACTION GROUNDED IN SCIENCE

The Coalition takes action based on solid science. Our activities follow a package of control measures identified by UN Environment and the World Meteorological Organisation (WMO) for their ability to achieve “win-win” results for the climate, air quality, and human wellbeing over a relatively short timeframe, at little to no net cost.

## HOW WE WORK

The Coalition supports action on the ground through 11 initiatives, which are designed to transform policies and practices and showcase practical actions that can quickly reduce short-lived climate pollutants in the main emitting sectors.
